Re: Notification of Intent to Impose a Fine

Dear Mr. Dollard and Mr. Sweeney:

This letter constitutes formal notification that the New York State Office for People With Developmental Disabilities ("OPWDD") is imposing a fine in the amount of \$10,000 on your agency, Center for Discovery, Inc. ("CFD").

Pursuant to Mental Hygiene Law section 16.17(g), the Commissioner may impose a fine upon a finding that the holder of an operating certificate has failed to comply with the terms of the operating certificate or with the provisions of any applicable statute, rule or regulation.

A resident (JG) of a CFD Individualized Residential Alternative ("IRA") was admitted to Garnet Medical Center ("Garnet") on or about November 17, 2021, due to certain acute medical conditions. On or about December 15, 2021, Garnet determined that JG's acute conditions had been resolved and that JG no longer required treatment in the hospital. Garnet advised CFD that JG was ready for discharge from Garnet. CFD nonetheless refused to return him to his home of fifteen (15) years.

By letter dated December 23, 2021, Director Joan Volpe reiterated to CFD that Garnet had determined JG to be ready for discharge. Ms. Volpe's letter dated December 23, 2021 also enclosed OPWDD's September 9, 2020 memorandum entitled "Due Process and Inappropriate Discharges from Residential Programs and Services." This memorandum described the requirements set forth in 14 NYCRR 633.12 and specifically defined an "inappropriate discharge" to include situations where a provider refuses to allow an individual to return to their residence after a period of hospitalization without following 633.12's due process procedures. CFD's failure to return JG to his home after he was ready for discharge and without giving him the due process protections established by 633.12 clearly amounted to an inappropriate discharge.

CFD only agreed to admit JG back to his residence after a court ordered CFD to immediately return JG to his residence and after CFD had exhausted all legal means to stay this order. He was not returned home until February 28, 2022, having spent more than 2 months languishing in the hospital unnecessarily. CFD's failure to promptly return JG to his residence or to provide him with the necessary due process under 633.12 is a violation of OPWDD regulations and the terms of CFD's operating certificate.

You have the right to an administrative hearing to appeal the imposition of this fine. You also have the right to be represented by an attorney at such hearing. If you are requesting a hearing, you have **30 days** from service of notice of this proposed action to submit your request. Your request must include a declaration of the issues alleged to be involved and documentation of the agency's position as to each identified issue.

In accordance with 14 NYCRR 602.5, your written request for the hearing must include a copy of this letter and a declaration of the issues alleged to be involved and documentation of your position of each issue. If you decide not to request a hearing, please remit payment of your fine immediately. Payment should be made within 30 days of receipt of this notification. Payment must be made by check payable to OPWDD and be for the total amount of the fine. Partial payment will not be accepted without written authorization from OPWDD. You may send your payment to:

Finally, please be aware that the imposition of this fine does not preclude OPWDD from taking further adverse action if your agency fails to maintain compliance with OPWDD regulations.
